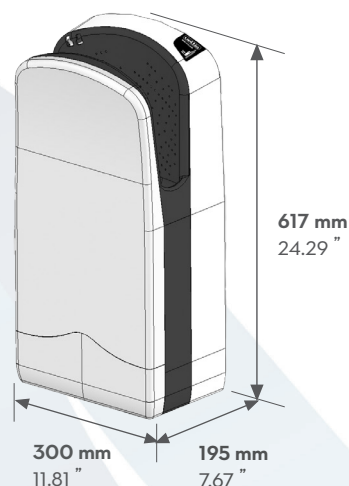
Housing case and water tank made of High impact 2.6 mm thick ABS with antibacterial protection in drying area.
